

## Greenwood Memorial Day Raffle Terms & Conditions

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This raffle is open only to those who receive an entry form at the Greenwood events who are 18 years of age or older as of the date of entry. The raffle is only open to legal residents of the United States and is void where prohibited by law. Employees of Greenwood, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, and immediate family members and those living in the same household of employees (collectively the “Employees”), are not eligible to participate in the raffle. The sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. **Agreement to Rules:** By submitting an entry, you agree to be fully and unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. 4. **How to Enter:** The raffle can be entered by completing an entry at Greenwood Memorial Park on Monday May 29<sup>th</sup>, from 8am to 5pm. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple entries, email addresses, identities, or devices in an attempt to circumvent the rules.
5. **Prizes:** The Winner of the raffle will receive Padres tickets for 4 people. No cash or other prize substitution shall be permitted except Greenwood’s discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of winning entry (“Winner”). Acceptance of prize constitutes permission for Greenwood to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

days from the time award notification was delivered, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited.
